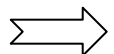

Renter shall be fully and solely responsible for any and all injury or damage to persons or property arising by reason of renter's use of the premises or any activity occurring as the direct or indirect result thereof, and shall hold Morrow County Fair Board and Morrow County harmless therefrom. The MCFB and Morrow County are not responsible for lost or stolen property. County property may not be removed from the premises, unless given prior permission.



Renter shall promptly pay the cost of any and all repairs to the premises which are required by reason of damages occurring during the period of renter's use. Except, however, normal wear and tear, and damages which result from an Act of God or other circumstances beyond the control of renter.

**Renter shall remove all trash, garbage and clutter and shall clean the premises so as to leave them in as clean, orderly and tidy condition as they were prior to renter's use. Tables and chairs shall be put away in their original place (next to the art exhibit wall). Renter has 24 hours for cleanup, unless prior arrangements are made.**

**Cleaning Deposit is refundable after inspection by Fair Manager or Caretaker. Separate check for cleaning deposit.**

If the use which renter proposes to make of the premises requires any State, Local or Federal permit, certificate of insurance, license or other document of compliance, renter shall provide proof and copy of such document.

**Certificate of Liability Insurance is required before time of rental.**

**Regarding the serving of alcohol, proof of Host Liquor Liability (by individual) or Business Liquor Liability (caterer, etc.) is required before time of rental.**
